2. Introduction of Ordinance NO. 290 - FY 2016 Operating and Capital Budget and Tax Rate and Introduction of FY 2016 – 2020 Capital Improvement Plan

– Mayor Shaw will introduce the FY 2016 Operating and Capital Budget and the latest FY 2016 – 2020 Capital Improvement Plan. This is just the beginning of the budget adoption process. Council members will have a chance to ask questions and make alternative proposals over the next month. A Public Hearing on the FY 2016 Operating and Capital Budget and FY 2016 – 2020 Capital Improvement Plan will be held on Monday, April 13. It is anticipated the FY 2016 Operating and Capital Budget and FY 2016 – 2020 Capital Improvement Plan and will be approved on Monday, April 27.

Recommended Action: No action required.

3. Introduction of Personnel Manual Change - Sick Leave Payout

The State Retirement System allows participants to receive additional months of service credit based on unused sick leave days if they retire within 30 days of separating from employment. Currently, the Town pays employees 20 percent of the value of their sick leave when separating from employment with the Town. The Town Manager proposes changing the policy so that employees who qualify for additional service credit for retirement receive that benefit instead of the 20 percent payout.

Recommended Action: No action required at this meeting.

4. Replacement of Cooper Park Wall in FY 2015

The Cooper Park playground is in need of a significant amount of engineered wood fiber this spring. The MTC indicated support for funding the replacement of the playground wall in FY 16. It makes better sense to replace the wall first and then add the fiber. Therefore, the Town Manager proposes that we replace the wall this spring with funds from the capital reserve and repay the capital reserve in FY 2016.

Recommended Action: Motion to authorize up to \$8,000 to replace the wall at Cooper Park with funding from the Capital Reserve with the Capital Reserve to be repaid in FY 2016.
