OFFICIAL MINUTES OF FEBRUARY 27, 2025 REGULAR PARKS AND RECREATION

Commissioner Valenstein will make an announcement at his church asking for filled eggs. There was discussion about signage for the egg limit and the different age areas. Commissioner Sevick will make signs for the limits. There will be volunteers there to hide the eggs.

Staff have been talking with the sound technician at Impact Church for guidance. There was discussion about having additional speakers.

 Here 'Til Sunday has confirmed for their concert in the park. Commissioner Ries asked for flyers to be made.

TOWN UPDATES:

- Mr. Rittenhouse explained that the Linear Trail Parklet has been in the
 location planning phase. The final location will be near the bench by the
 spring house. Public Works will determine if there is rocks under the
 location and if a concrete pad would be able to be poured. An interpretive
 sign can be added to that area discussing the spring house.
- Mr. Rittenhouse has jumped on social media and website updates. He will continue sharing community and Commission information. He will add the movie sponsors to the website.
- The bulletin board in Millard Cooper Park will have flyers and a QR code to the website with the calendar.
- The new "Park Rules" signs have been ordered and will be put up in every park.
- Mr. Rittenhouse cleaned out the basement and organized it with all the SPARC equipment.
- There are three Sycamore trees in Millard Cooper Park that are dead and one that is dying. An arborist will be consulted to ensure they are fully gone.
- New fencing has been ordered for around the splash pad.
- There is 88 days until splash pad opening!
- Public Works has extra dirt and mulch that they put in Millard Cooper Park to address some erosion that has occurred. The mulch has been put in all

the playground areas too.

Ries motioned, and Commissioner Valenstein seconded to adjourn the

meeting at 7:47 P.M.
