On August 4th, Members of the Town Council, Town Administration and I were delighted to join the Downtown Sykesville Connection in welcoming Governor Larry Hogan to Sykesville. The governor graciously made Main Street one of his stops on his tour of Carroll County. I had just been in a two week long conversation with his staff about my request for a letter of support from the Governor for the Downtown Sykesville Connection's application to the Great American Main Street Award. Not only did he write the letter, he hand delivered it! His visit provided Sykesville with some very well deserved statewide attention and is certainly one of my favorite mayoral experiences to date.

A prevailing topic of discussion was the recent Board of County Commissioners decision to forgo again the collection of impact fees from developers who are building residential units in our county, specifically in the Freedom District—a Designated Growth Area. The commissioner then held a District 5 Town Hall to allow for the public to weigh in on these issues.

8 SAFETY TIPS FOR DRIVERS

- 1. Look out for pedestrians everywhere, at all times.
- 2. Use extra caution when driving in hard-to-see conditions, such as nighttime or bad weather.
- Slow down and be prepared to stop when turning or otherwise entering a crosswalk.
- 4. Yield to pedestrians in crosswalks and stop well back from the crosswalk to give other vehicles an opportunity to see the crossing pedestrians so they can stop too.
- 5. Never pass vehicles stopped at a crosswalk. There may be people crossing where you can't see.
- Never drive under the influence of alcohol and/or drugs.
- 7. Follow the speed limit, especially around people on the street, in school zones and in neighborhoods where children are present.
- 8. Be extra cautious when backing up and look for pedestrians.

8 WALKING SAFETY TIPS

- 1. Follow the rules of the road and obey signs and signals.
- 2. Walk on sidewalks whenever they are available.
- 3. If there is no sidewalk, walk facing traffic and as far from traffic as possible.
- 4. Cross streets at crosswalks or intersections. Look for cars in all directions, including those turning left or right.
- 5. If a crosswalk or intersection is not available, locate a well-lit area where you have the best view of traffic. Wait for a gap in traffic that allows enough time to cross safely; continue watching for traffic as you cross.
- 6. Watch for cars entering or exiting driveways, or backing up in parking lots.
- 7. Avoid alcohol and drugs when walking; they impair your abilities and your judgment.
- 8. Embrace walking as a healthy form of transportation get up, get out and get moving.

We are proud to announce the newest additions to our police department. Officers Joel Pichardo and Morgan Hoppa successfully completed the 26-week entry level training program held at the Maryland Police and Correctional Training Commission on Friday September 2, 2022. Both were previously members of our Police Auxiliary Unit prior to entering the academy. They will now undergo 6 weeks of intensive training with a senior officer before patrolling on their own. Gate House Museum

This September, the Gate House reached its 25th anniversary of opening. In commemoration of this milestone, major renovation is afoot and a-ceiling and a-wall. Your patience as we navigate electrical updates, painting of archive spaces, and other limitations to our daily operations is greatly appreciated. This work will allow for greater research capacity and faster digitization of our archival collections, as well as provide us with additional display space on the second floor.

The Gate House is supported by the Town, volunteers, and generous donors of objects, funds, and oral histories. In 1997, when the Town purchased the little stone house adjacent to a mostly-empty Millard Cooper Park for \$100, the building had numerous problems structurally and had to navigate two separate battles with termite damage. Thanks to the stewardship of the Town, dedicated volunteers, and a collection of curators with diverse skills and great hope, the museum has collected over 1,500 objects, has welcomed over 6,800 guests, and is ready to sturdily face its next quarter century.

Until the 1980s, many long-time residents of the Town referred to Sykesville as "the village." The expansion of our village in recent decades has ushered in new caretaker-residents. We hope that you will take time this fall to visit the Gate House

and find out about our town's history, share the objects, images, and stories of your past, and learn about how those before us made this village into the growing Historic Town it is today.

The museum is currently accepting donations of objects relevant to our upcoming 1950s and 60s-themed exhibit. Please call or stop by the museum for details on the donation process. 410-549-5150

SAFETY FIRST

id you know...

On average 15-20 children regularly cross Spout Hill Road every school day morning and afternoon on their walk to and from Sykesville Middle. Since 2005, I've been instructing them to pay attention to the northbound traffic at the top of the hill, particularly on their walks home since this coincides with the change-of-shift nursing home traffic on Second Avenue. Watching from my home office window, I hold my breath as the small packs of children approach the intersection of Second Avenue and Spout Hill.

I have asked staff to research solar powered beacons for strategic placement on the north and south bound lanes. The beacons will only illuminate and blink for one hour in the mornings and afternoons on school days. I hope to breathe a little easier on school days, as the beacons will certainly alert all commuters in both directions of the sixth, seventh, and eighth graders making use of Second Avenue and crossing Spout Hill Road.



The Hatton Animal Rescue Foundation

WARFIELD DEVELOPMENT UPDATE

You may recall that in June Council President Anna Carter, Councilmember Leo Keenan and I, along with Town administrative staff, had a meeting with the developers and the Maryland Department of Housing and Community Development (DHCD). In that meeting, DHCD proposed changes to the sales contract's escrow agreements. These agreements were created to ensure that the historic buildings in Warfield would be stabilized. DHCD's proposed change to the escrow agreements was the one fruitful thing to have come out of that meeting. In the nearly five months since the meeting, this potential progress has not been realized.

The DHCD's recommended changes could facilitate the Town's release of money to the developers which are being held in said escrows. By now that escrow should contain \$2.1M. But the developer has not deposited the additional \$1M into that escrow which was due in June 2020. That note not having been satisfied places them in default of the sales contract. Additionally, to date, the developer has been reluctant to spend money from one of these accounts due to their tax liability associated with expenditures on stabilization or any improvements to the historic structures. Reportedly, if these funds are instead spent on infrastructure, the developer's tax liability is reduced. I made it clear in that meeting that the Town is willing to consider releasing the current escrow money to the developers for use on other site preparation activities but only after requiring equivalent developer investment (\$2.1M) in the buildings. It was the Town's understanding that these changes were pending and were to be expected from the developer shortly after the meeting on June 9th.

Alas, no proposed revisions to the escrow agreement from the developer have been received. In fact, there has been no direct communication of substance from them since that meeting. The Town Council and I are in discussions with the Town Attorney regarding next steps.

B.F. SHRIVER CANNERY WAREHOUSE AT SOUTH BRANCH PARK

id you know...

South Branch Park is outside our municipal boundaries and in fact is in Howard County? Sykesville and Howard County entered into a cooperative agreement in December 2006 wherein Sykesville leases South Branch Park from Howard County, including the park's three remaining historic structures, for a cost of \$1 per year. The Town of Sykesville is responsible for all park maintenance. This cooperative agreement expires in December 2041 and can of course be renewed.

Did you also know...

This cooperative agreement between Howard County and Sykesville requires that the Town, "create a recreational area to be used primarily for recreation, historic and cultural purposes and to preserve, rehabilitate and operate for public use the historic structures on the property."

The park's historic structures include the stone mill house, the weigh station and the large brick warehouse. Since 2006, multiple stabilization projects have been completed and ongoing maintenance to these historic structures continues. More prominent improvements to the park include the installation of the pavilion, playground, skate park and, most recently, the pervious paver parking lot. But the South Branch Park improvement that holds some of the greatest potential for Sykesville—the redevelopment and reuse of the 1917 BF Shriver Cannery warehouse (also sometimes referred to as the apple butter warehouse, so called for a more recent use of the building)—is finally getting underway.

You may recall that...

Sykesville has been awarded \$2M through a legislative bond initiative (LBI) to support the redevelopment of the warehouse. LBI funding is made available from the State for local or non-state owned capital projects. These projects typically include various cultural, historic, health, educational, and economic development projects not funded by other state capital grant and loan projects.

Now the project begins...

The first step in the redevelopment of the warehouse is a four-phase scope conducted by the DeVos Institute of Arts Management at the University of Maryland which is expected to last 6-8 months.

Phase I: Engagement and Analysis

A community engagement process that yields resident, stakeholder, and local artist insights on desired uses and functions of the warehouse

Phase 2: Mission & Vision Building

A Mission and Vision for the development will be established as a result of the fusion of engagement and analysis. These statements will express the value the enhanced warehouse will provide on a local, regional, and national basis, as well as indicate key program areas (e.g. performance, education, workforce development)

Phase 3: Conceptual Site Plan

Here we will work with the Town's appointed architect and master planner to develop a conceptual site plan, or "bird's eye view" of the site, as well as a concept for the adaptation of the warehouse for established uses

Phase 4: Business Plan

A Business Plan for the new operation, illustrating both the up-front capital required to build and the ongoing revenue and expense flows to be anticipated.

In the meantime, the Town is working with State Highway Administration on the pedestrian connection between the park and Main Street.

Give and accept wrapped or packaged candy. Examine all candy before consumption.




Adults should accompany young children at all times.
