COUNCIL COMMITTEE REPORTS

Planning Commission (PC) - Julia Betz

Since the last Mayor & Town Council meeting, the Planning Commission (PC) met on September 5.

- The Freedom Community Comprehensive Plan went to the Carroll County Commissioners on July 28, and there is a 90-day review period. The County informed the PC that there will be a Board of Carroll County Commissioners (BCC) open forum for the public to discuss the Freedom Plan on September 21 at 7 p.m. at the South Carroll Senior Center. On October 19, there will be a public hearing for the Freedom Plan at Liberty or Century High School at 7 p.m., and the BCC will be making a final decision on the Freedom Plan at its October 23 meeting.
- Warfield Items
 - Pattern Book The PC received Version 5.0 of the Pattern Book to review and corrections were discussed. This should be the last round of corrections that are necessary, so a vote to approve the Pattern Book is anticipated at the next PC meeting.
 - Elevations/Grading Plan The PC was provided with the minutes from the last Sykesville Historic District Commission (HDC) meeting on August 28, 2017 as well as Richard Wagner's (of David H. Gleason Associates = Town consultant) memo dated August 22, 2017 to review all of the information discussed/provided regarding elevations and the grading plan. After being shown and discussing the drawings/sketches provided by Morris & Ritchie Associates (MRA), the PC concurs with the vote taken by the HDC at its August 28, 2017 meeting to approve Scheme B for the stepped system for Parcels E/F based on the memo dated August 22, 2017 from Richard Wagner, with the understanding that the applicant will maintain consistent elevations from the second floor level to the roof peak on a minimum of the two center bays of each stick (of townhomes), with grade changes accomplished at the rear garage level.
 - Springfield Hospital Center (SHC) and Department of General Services (DGS)
 Response to Traffic Analysis SHC with the DGS provided written comments
 dated August 31, 2017 regarding the traffic study information they were given
 on July 17, 2017 (they had 45 days to respond). Further discussion/meetings
 with representatives from SHC, DGS, MRA, and Town staff will be necessary to
 resolve the concerns about increased traffic and road maintenance.

The next Planning Commission meeting is scheduled for Monday, October 2, at 7 p.m. at the Town House.

Historic District Commission and Gate House Museum - Stacy Link

Everything is going well and the museum continues to get decent traffic, but since the Smithsonian Exhibit ended, it has dropped off. Soon the curators Jack & Andrea White, are going to come up with a plan for driving more traffic to the museum.

They have designed the final three wall pieces for the 100 years ago exhibit, and once he gets a deposit, the contractor who does the work will get started. We should have them on the wall within two weeks.

We're also about to purchase a TV and speaker for the one remaining available spot on the wall. Mark Onheiser will help to install it. The curator can run PowerPoint displays on various subjects including our displays. We'll begin developing displays shortly. When the museum is

open these displays will run continuously and will include sound. We should have this ready within two weeks also, but developing the content will be ongoing and start out simple.

The GH Museum hopes to put out a new newsletter this fall and are planning an event for Veterans Day that will probably be related to our WWI display, but we haven't developed the details yet. Once the TV and the final displays are up, we'll turn our attention the newsletter, social media, etc., and creating events to build up our visitorship and community presence.

We also have an intern, a recent college grad with a history degree, who happens to be Jack & Andrea's daughter, who will be working on the huge archiving project. We will have an entry and a photo of every item in our collection stored in a database for easy searching. Including documents and photos there are probably over 4000 items.

On a side note, the school and library systems of Carroll County have selected Jack's book, In Carrie's Footprints, for their first ever One Carroll One Book. They will be using the book in all kinds of ways this year to promote friendship and respect between all the different kinds of people who live here. They're involving the colleges, government, businesses, all kinds of organizations, whatever they can come up with. It should be pretty cool. Lots of smart people working on it.

Warfield Development Corporation and Town Updates - Ian Shaw

The WDC has not met since our last meeting. Efforts continue with the Sate and the County to come to terms on a final payoff scenario, as they decide that what they had agreed to prior was not obtainable from the State and the County was unable to honor the agreement that we had in place in June 2017.

We are working vigilantly to expedite a response from the State and County one that we can negotiate and get to you for approval as soon as possible.

We have a joint meeting with County, Town and TWC to discuss work plans and timelines on 9/13/17

Town Items:

- The Interim manager has started as you are all aware and David is getting up to speed gradually.
- We have met with the HOA and the Developer at Raincliffe and are working on trail alternative plans that the Planning commission wanted.
- 7610 Main Street had some issues in the final build out that are being addressed by the planning commission and staff. They were approved to open and hopefully, they will go smooth. Connectivity to Main Street and some plan variations from the approved plan are the items being addressed. With the tear down this likely should have required a site plan. Unfortunately, it started as a remodel and became new construction without a site plan. That created some confusion for all. We are committed to working with them as well as the State to get the front sidewalk safety issues addressed as soon as possible.
- Discussions have continued with the draft of the Contract for 714 Sandosky Road Property and we anticipate having this for your review prior to the 9/25/17 meeting.
- Additionally, The Main Street MOU for the Creation of the Non Profit is being discussed and next steps will be determined. I will advise once a plan is in place.
