Mayor Shaw, Council President Betz, myself, Rich Austin and Fred Gossage (by phone) from the Main Street Board Members met on September 19 to discuss the MOU for the separation of Main Street from the Town. I will take the requested changes back to the Board at a meeting on September 28, and hope to present a final draft for review by the full Council at our October 10 meeting.
- 2. Farmers Market is entering its' final weeks, wrapping up on October 29. This year's "Harvest Festival" is being incorporated into one of the Farmer's Market dates on October 8, with additional vendors, and expanding the time to 3 p.m., and expanding on to Main Street. The Mayor and Town Council will set up a "meet and greet" at the porch on the Town Hall with hot dogs and water to give away during the Harvest Fest. I will supply the materials. - 3. Promotions Committee and Economic Development met on Tuesday September 12 to continue planning for upcoming events and to begin setting plans for 2018 events. The next upcoming major event is the Craft Beer Festival on Saturday November 4 from 12 p.m. to 5 p.m. on Main Street; we have eliminated the chili competition from this Festival due to the cost factor for the chili vendors they were running out of chili by 2 p.m., and it costs them too much money to make enough for the event. This year's festival will feature craft beer and food trucks. Some details are below:
 - 1. Sponsors EWB, Market Tavern \$1500 ea, Tevis Oil, Assist 2 Sell = \$4500 total
 - 2. Vendor 10 food to date. 12 retail vendors to date
 - 3. Entertainment Garret Mabe Trio opening act; Soundtown Baltimore 2nd act; wireless speakers along street
 - 4. Chili contestants are asking about contest we will reach out and ask if they would be interested in next year's Harvest Festival
 - 5. Beer 10-12 confirmed; goal = 30
 - 6. Volunteers sign up genius is out and is beginning to fill up

For 2018 events, initial thoughts are to eliminate the IceFest daytime activities and replace them with a gala at Baldwin's. Another idea, in order to avoid the fiasco that took place on Mother's Day this year, is to have a Flower Festival on the Saturday before Mother's Day in one of the parking lots, and hold off on the Farmers Market until the following weekend. A full proposed schedule for 2018 will be provided to the Council at a November meeting for review and approval by the Mayor and Town Council.

4. Ghost Tours have been renewed for this year, with George Carter acting as the tour guide. I believe that the most dates are already sold out.

- 5. Firehouse Creamery is now open and has been a huge attraction for visitors downtown, particularly with its outdoor seating area. It's great to see the increased overall foot traffic downtown on a daily basis.
- 6. Attached is the August financial report for Main Street. The figures do not include \$8,621 in the account at Carroll Community bank, and \$13,270 in our Paypal account.
- 7. On Tuesday September 19, Julie attended the required quarterly Maryland Main Street Association meeting, held this time in Rock Hall, Maryland. In her own inimitable fashion, her update on that meeting was as follows: *Omg!Omg! I love these meetings:* so much creativity, so many questions answered and great ideas!! I promise to keep them off the MTC agenda/meeting until you and the rest of the board approves. I am very excited though:)
