# OFFICIAL MINUTES OF JANUARY 9, 2018 REGULAR COUNCIL MEETING NO. 18-01

The Council meeting of the Town of Sykesville was held on Tuesday, January 9, 2018. Mayor Shaw called the meeting to order at 7:00 P.M. in the Council Meeting Room at the Town House. Mayor Shaw led the Pledge of Allegiance and a moment of silence.

TREASURER'S

**REPORT:** November 2017

Evelyn Sweet, Town Treasurer, reported that there will be budget adjustments at the next meeting. She also announced that Catonsville Homes, LLC stopped paying their invoices. They have not been billed since they stopped

paying. She and Mayor Shaw will discuss how to proceed.

approve the November 2017 Treasurer's Report.

**PUBLIC SAFETY** 

**REPORT:** Chief Spaulding presented the Public Safety Report for the period of December 8,

2017 through January 4, 2018. He explained how the new breakdown of the report worked. There was a total of 648 reports including 30 foot patrols, 17 incident

reports, 355 patrol checks, and 53 traffic enforcement initiatives. Chief Spaulding explained that he is still working out the bugs in the system, which is why there are 21 incidents detailed and only 17 reported.

Chief Spaulding explained that the bullet found at Sykesville Middle School was not a live round and had been previously fired. It was found by staff and disposed of by the Police Department.

He also explained that the vandalism at Warfield continues even with the patrol checks done by officers. Sergeant Kilgore found a man spray painting the tunnel leading from Millard Cooper Park to the Warfield Complex. He had the young man clean off the spray paint instead of being charged.

Chief Spaulding announced that today is Law Enforcement Appreciation Day. The Mayor and Council thanked the Chief and his officers for everything they do to help keep Sykesville a safe town. Council Member Grasley thanked them for their quick response to his call.

Chief Spaulding is working on compiling the yearly stats to report to the Mayor and Town Council. It is the first year entirely with the Records Management System.

The open police officer has been advertised for and 40 applications were submitted. Chief will be bringing in the top applicants for interviews soon.

There were no major incidents during the ice event that occurred. The officers try to contact owners of cars parked along snow emergency routes to give them a chance to move the car before getting ticketed or towed.

- Mayor Shaw announced that Aretha Adams was hired as the new Town Manager.
   She will begin on February 5. He and the Council thanked all of the staff and citizens involved in the thorough interview process.

1. Public Hearing on Ordinance NO. 301 – to amend, adopt, and enact sections of the Town Code of Sykesville to: (1) Amend Chapter 51 to reference the existing section as Article I and update the references therein to the County animal regulations; and (2) Adopt and enact a new article II in Chapter 51 regarding animals at Town events

Chief Spaulding explained the ordinance to those in attendance. This ordinance was also requested by Julie Della-Maria and the Downtown Sykesville Connection to increase safety by not allowing pets at events.

There were no public comments.

The motion carried unanimously.

#### 2. Consideration of Ordinance NO. 301

Council President Betz provided a revision to Ordinance NO. 301. In the bold section under the whereas recitals, in the third line, it should say "Section 51-1 as set forth..."

#### **MOTION:**

Council Member Link motioned and Council Member Grasley seconded to adopt Ordinance NO. 301 – to amend, adopt, and enact sections of the Town Code of Sykesville to: (1) Amend Chapter 51 to reference the existing section as Article I and update the references therein to the County animal regulations; and (2) Adopt and enact a new article II in Chapter 51 regarding animals at Town events with the revision provided by Council President Betz.

The motion carried unanimously.

The Downtown Sykesville Connection will work on signs to be placed at the entrances to the events about pets not being allowed to enter.

### 3. Approval to apply for the MHT Capital Improvement Grant

Jared Schumacher, Circuit Rider, was in attendance to answer questions about this item. The due date for the Letter of Intent to Apply was moved to February 1, 2018. Funds should have a fairly quick turnaround because of the upcoming end to the fiscal year. There is a one for one match with the grant funding, however, labor can be used as part of the match. Mr. Schumacher has discussed with Jack White, Curator of the Gate House Museum, how to use volunteer hours and work for the labor portion.

The Mayor and Council agreed and gave their consent for Mr. Schumacher to move forward with the grant process.

# 4. Consideration of Resolution NO. 2018-01 allowing alcohol to be sold at Downtown Sykesville Connection events

The Downtown Sykesville Connection provided this resolution with all of their events listed so they do not have to come back to the Mayor and Town Council for a resolution for each individual event. Council President Betz provided some corrections for this resolution. In the Farmers' Markets bullet, the September dates should be September 2, 9, 16, 23, and 30. In the Craft Beer Festival bullet, the word "Saturday" should be inserted before November.

### MOTION:

Council Member True motioned and Council Member Keenan seconded to approve Resolution NO. 2018-01 allowing alcohol to be sold at the Downtown Sykesville Connection events with the revisions provided by Council President Betz.

The motion carried unanimously.

## 5. Development Fee Schedule Update

David Deutsch, Interim Town Manager, explained that he has been researching this and checking with surrounding jurisdictions about their fee schedules, as the Town's hasn't been updated in a long time. He explained that there are some fees that he can't find out when they were last updated. He is putting together a list of all fees, not just development fees, so it will be easy to review each year and update as needed. He will present this at the next meeting.
