OFFICIAL MINUTES OF DECEMBER 10, 2018 REGULAR COUNCIL MEETING NO. 18-23

The Council meeting of the Town of Sykesville was held on Monday, December 10, 2018. Mayor Shaw called the meeting to order at 7:00 P.M. in the Council Meeting Room at the Town House. Mayor Shaw led the Pledge of Allegiance and a moment of silence.

COMMENTS: There were no public comments.

TREASURER'S

REPORT: October 2018

Evelyn Sweet, Town Treasurer, was not in attendance to present the October 2018 Treasurer's Report, however she did answer questions prior to the meeting. The distance paid to one of the officers was travel time to a previously used vendor for uniform fittings. They are now using a different vendor that is closer and provides better customer service.

MOTION: Council President Betz motioned to approve the October 2018

Treasurer's Report. Council Member Grasley seconded the motion.

The motion carried unanimously.

PUBLIC SAFETY

REPORT:

Chief Spaulding presented the Public Safety Report for November 19 through December 2, 2019. There were a total of 334 reports including 13 assist other agencies, 3 community policing, 15 incident reports, 163 patrol checks, and 34 traffic enforcement initiatives. Chief Spaulding explained that traditionally there are more DUI stops during the holiday season and the officers do run grant funded DUI checks. Chief Spaulding also explained that there are still issues with Birch Manor. There is little the Police Department can do to prevent or lower the reports at Birch Manor because the facility is required to report the incidents and the Police Department is required to respond.

Chief Spaulding announced that overdoses are up in the county for 2018. There was a fatal overdose in Town, a person who was here visiting overdosed, and the officers responded, preforming CPR prior to the ambulance and rescue personnel arriving.

Chief Spaulding presented an update for the speed trailer. It has been deployed recently on Obrecht Road, Main Street, and Sandosky Road because of the cut through traffic from the construction. There was discussion about retrofitting the trailer to have a camera to take pictures of the license plates of speeders. It would be a lot harder to retrofit and would require legislation from the Council.

MOTION: Council Member Link motioned to approve the item on the Consent Agenda. Council Member True seconded the motion.

II. (2018-89) End of Year Public Works Department Updates

Derek Shreves, Public Works Director, presented an end of year update regarding the Public Works Department. Mr. Shreves explained that the "Big Red" snowplow and dump truck is quickly deteriorating, and a replacement will be needed. Residential and commercial trash pickup for 2018 has increased 3.4%.

III. (2018-90) Presentation of and Consideration of the Updated Town Zoning Map Mark Onheiser, Special Projects Coordinator, presented the updated Town Zoning Map. He explained that a couple street names were corrected and street names were added to roads that were previously unmarked.

MOTION: Council Member Grasley motioned to approve the updated zoning map. Council Member Keenan seconded the motion.

The motion carried unanimously.

IV. (2018-91) Discuss/Consider/Act on Selection of an Engineering Firm to Provide a Connectivity Study for the Town

Jared Schumacher, Circuit Rider and Grants Manager, presented the engineering firm for the connectivity study. He explained that the Town was awarded a \$30,000 USDA grant for a connectivity study. From the Request for Proposals, the Town received eight bids, all within budget. RK&K stood out because their bid was the most well organized and detailed, and they had the best references. RK&K will start as soon as a notice to proceed is sent, and the project should take three to six months. The majority of their work will be in office, so weather should not be much of a factor in the timeframe.

MOTION: Council Member True motioned to accept the bid from RK&K Engineering in an amount not to exceed \$40,000. Council Member Link seconded the motion.

The motion carried unanimously.

COUNCIL AND MANAGER COMMENTS:

Council thanked the Police for the safe road closure for Santa's Arrival on Main Street.

MOTION: Council President Betz motioned and Council Member Grasley seconded to take a five minute recess at 8:05 P.M.

The motion carried unanimously.

MOTION: Council Member True motioned and Council Member Keenan seconded to go back into open session at 8:16 P.M.

The motion carried unanimously.

CLOSED SESSION:

(14) Before a contract is awarded or bids are opened, discuss a matter directly related to a negotiation strategy or the contents of a bid or proposal, if public discussion or disclosure would adversely impact the ability of the public body to participate in the competitive bidding or proposal process.

MOTION: Council Member True motioned and Council Member Keenan seconded to go into closed session at 8:17 P.M.

The motion carried unanimously.
