#### **Business**

Planned Employment Center (PEC) Preliminary Plan Review Process

The Town has begun the process of reviewing a Preliminary Plan for The Enclave at Parkside: a 47-unit townhome subdivision adjacent to the existing Parkside at Warfield development.

The preliminary plan approval process involves steps from the Planning Commission and Town Council. Should each step be completed during the course of a single meeting, we can anticipate the process being completed, at the earliest, by the September Planning Commission meeting.

Commissioners are under no obligation to make recommendations or take votes before they feel ready. The Commissioners are free to ask questions to the applicants at any point in the process to better understand the plan. When the preliminary plan comes before the Planning Commission for a vote, it is encouraged that the Commissioners refer to the Town Code and clearly indicate how the plan aligns with the Town Code, or not, when deciding to approve or deny the plan. Any suggested changes to the Preliminary Plan by the Planning Commission should also contain specific reasoning as to how the change would better meet the requirements of the Town Code.

During the July 5 Planning Commission Meeting the applicant is expected to give a presentation of the Preliminary Plan for The Enclave at Parkside. Also, the Planning Commission will review the Adequate Public Facilities Agency letters and make a recommendation to the Mayor and Town Council.
