<u>Call to Order:</u> Steve Enslow, Chairman, called the meeting to order at 7:05 PM.

#### **Approval of Minutes**

Motion was made by Chair Enslow and seconded by Commissioner Singleton to approve the September 8, 2015 Planning Commission meeting minutes. All voted in favor, Commissioner Cinkole abstained. Chair Enslow requested one correction and all agreed that under Streetscape Task Force – Update, in the last sentence to remove "He also" and replace with "Commissioner Singleton".

### **BUSINESS**

## Presentation of Warfield Land Condominium

As part of the sale of the Warfield complex, the parcel with the historic buildings, Parcel D, will be setup as a land condominium. Dennis Hoover, Town Attorney, explained what this means and how the land condominium works.

A land condominium requires two components, units and common elements. Each historic building is a separate unit. This allows for the buildings to transfer individually.

There is a component in the contract that requires a portion of the purchase price to go into an escrow that will be dispersed back to the purchaser for improvements to the historic buildings. The escrow will be released back to the purchaser, as if it was a grant, with a dollar for dollar match by the purchaser. These funds will be spread across each building based on the square footage of each building. If the buildings are not stabilized and preserved according to a prescribed schedule, they will revert back to the Town. The Land condominium provides a mechanism for the buildings to revert individually.

## **County Updates**

- Mt Airy is also working on a Distillery text amendment; Andrea Gerhardt advised that it may be beneficial to plan a joint meeting with them.
- On October 22 there will be a public hearing regarding the rezoning for Walmart in Eldersburg.
- The Carroll County/Sykesville Joint meeting is scheduled for November 4, at 7 PM. Possible agenda items are:
  - o County Gateways and signage
  - o Annexation of property and zoning waivers
  - National Guard Readiness Center on Route 32
  - Warfield
  - o Communication
  - o Infrastructure for fiber optics

## <u>Update on Streetscape Project</u>

SHA presented a revised concept plan to the Mayor and Town Council; it includes parking, wider sidewalks downtown and a plaza in front of the Town House.

The Mayor and Town Council decided to retain a consultant to assist with the SHA project and review the concepts from an economic perspective (parking versus wider sidewalks). The Town Manager will be meeting with three different consultants before choosing one.

## **Update on Town Issues**

The Planning Commission was asked to review the Downtown Revitalization chapter of the Master plan for input on a cohesive Town vision that will tie together the following ideas.

- o Town House Plaza
- One way traffic on Oklahoma and how it would affect Baldwin's Station
- o South Branch Park
- o Warfield

#### **Eagle Scout Projects**

- Construction of a 12'x24' pavilion with one adult wheelchair accessible picnic table and one children's picnic table at Little Sykes.
- Construction of four 3'x2.5' cold frame boxes, a four-sided frame of boards with a removable glass or plastic top. The frame is placed on the ground and is used to house, protect, and harden off seedlings and small plants, without artificial heat.

#### Concerns:

Any additions to the Town could increase the workload of the Public Works Department.
