### **Background**

### Use of Capital Reserve for Baldwin's Station roof repair

We have received a favorable estimate to repair the roof on Baldwin's Station (see attached). Funding is included in the FY 2017 budget. However, it has been difficult to find contractors at a reasonable price. We are concerned that if we wait until July 1 to award the contract, the contractor will be unavailable. This is to request authorization to hire this contractor so work can begin immediately. The Capital Reserve will be repaid with FY 17 funds.

# **Linear Trail Bridge**

In FY 2015, the Town received a Program Open Space (POS) Grant in the amount of \$32, 664 to repair the Linear Trail Bridge (application was submitted in May 2014). This grant has a 5 percent match. Due to the recommended design at the time, the Town also applied for a State Highway Administration Recreation Trails grant and was awarded \$20,000 for this project. We have a new design which is less costly. Our plan is to use the POS grant to purchase the bridge and the SHA grant for the labor to install it. Because the cost of the bridge was greater than \$10,000, the Town advertised a request for bids. We received two bids. The low bid was \$22,560 from MAADI Group Inc. However, there are some other factors being considered. More information about bidders is attached. A recommendation on who to award the contract to will be made by Monday.

### **Groundwater Easement (Warfield)**

Recently Carroll County was made aware from the Maryland Department of the Environment that wells that were drilled in and around the Springfield property were up for renewal for water allocations. It was thought that the permits expired and the appropriations were no longer available. However, the County was able to renew the allocation permits for approximately 1 million gallons a day of water and the State is allowing the County to get acceptance of the easements for future treatment buildings and water supply lines. One of the easements includes a 70 foot section +/- of Town of Sykesville property. The actual wells are north of the easement area on state property. The Perpetual Easement and Plat documents for the well water line easement that crosses the future Warfield property are attached.

### 8:00 PM OPEN SESSION:

**4.** Public Hearing on Ordinance NO. 295 – FY 2017 Operating and Capital Budget and Tax Rate – Mayor Shaw will open the Public Hearing to the public and ask for questions and concerns. Public comment will be in response to the budget proposed on April 11, 2016.

**Recommended Action:** The Public Hearing will remain open until the next meeting on Monday, May 9, at which time the Public Hearing will close.

5. Public Hearing on Proposed Real Property Tax Rate – Mayor Shaw will open the Public Hearing on the Proposed Real Property Tax Rate to the public for questions and concerns. The Mayor's proposed budget has the Tax Rate remaining the same at \$0.35 per \$100 of Real Property Assessment. However, the assessable base will increase by 1.9% resulting in \$26,036 of additional revenue to the Town. The real property tax rate must be set at the constant yield tax rate hearing, or at a later time if the day, time, and location the tax rate will be set is announced at the hearing. The Personal Property tax rate is also proposed to remain the same at 2.5 times the rate for real property or \$0.875 per \$100 of assessed property value. The tax rate will also be included when the budget ordinance is adopted at the May 9 meeting.

Recommended Action: Close the public hearing.

**6. Discussion of FY 2017 Operating Budget, FY 2017-2021 Capital Improvement Plan (CIP), and FY 2017 Tax rate** – Mayor Shaw will open the discussion of the FY 2017 Operating Budget, FY 2017-2021 Capital Improvement Plan (CIP), and the FY 2017 Tax rate to the Council. At the April 18 Budget Work Session, there were several changes recommended by Council members. The revised budget is attached for consideration. Of specific note are changes in the FY 17 capital budget.

**Recommended Action:** Discuss all items as outlined and announce the Public Hearing will close at the next meeting on May 9 at which time the Mayor and Town Council will vote on the FY 2017 Operating Budget and FY 2017 Tax rate. The CIP will be reviewed by the Planning Commission on May 2.

If in agreement, motion to adopt the Town's FY 2017 tax rates at \$0.35 per \$100 of Real Property Assessment and \$0.875 per \$100 of Personal Property Assessment.

7. FY 2017 Program Open Space grant application – Contrary to earlier information, the Town of Sykesville is in the rotation for POS funding in FY 2017. The application is due May 20, 2016. After consulting with Council Member Carter, Parks and Recreation Liaison, and staff, the top recommendation is to fund improvements to Cooper Park to make it more accessible to those with mobility issues.

**Recommended Action:** Make a recommendation to the staff as to what project the Town should focus on and apply for this grant.
