# **Background**

## 1. Approval of Town Employee pricing for rentals of the Tower

There was an inquiry about employees renting the Tower above the Post Office at a reduced rate. The current rate for half a day for non-Town residents is \$150 and for Town residents it is \$100. There is a \$75 cleaning deposit that will remain the same. The proposal is to reduce an employee's price to 50% of what they would normally pay plus the \$75 cleaning deposit.

# 2. FY 17 Budget Amendment for 714 Sandosky Road purchase

The purchase of 714 Sandosky Road requires a budget amendment to transfer the funds from the Unrestricted Fund Balance. After considering the rent that has been paid already, the net budget amendment needed for the purchase is \$174,505. The Unrestricted Fund Balance after the deduction of the \$174,505 totals \$1,233,514.
