1. Farmers' Market Location

This was discussed briefly at the last meeting. It was decided to allow staff to look into what will be needed to have the Farmers' Market at the 714 Sandosky Road property. Staff are ok with the new location. No parking signs will be installed on Mellor and College Avenues. The bathrooms in the building will not be open to the public. There is not a plan to provide portables on site but there will be one portable at Little Sykes. In addition, staff is still discussing safety for uses inside the building.

2. Approval of Circuit Rider Resolution and Memorandum of Agreement

Resolution NO. 2017-02 authorizes the Town to participate in the Circuit Rider Program for the Program Years 2018 and 2019. The Memorandum of Agreement is between the Town and the Maryland Rural Development Corporation (MRDC). The schedule for the Circuit Rider employee will average 40 hours per week and the Town will be billed a total of \$1,250 annually. The contract is renewable biannually.
